To expedite processing, complete application (Please print) and submit with the following:

1. The master association resale capital assessment approved by the Dunes of Naples Property Owners Association Board of Directors will be included in the estoppel. The resale capital assessment is the **greater** of the following: (a) \$1,000.00 or (b) the 0.32% of the gross selling price.
2. The attached purchase application, executed sales contract and application fee must be submitted to the Management office at least thirty (30) days prior to closing. Approval must be received prior to closing.
3. A copy of the signed sales contract between parties must be submitted along with the application. Contract sales price must be legible.
- 4. A MANDATORY CRIMINAL BACKGROUND CHECK MUST BE SUBMITTED.**
5. A \$100.00 non-refundable application fee made payable to [Dunes of Naples II Condominium Association](#).
6. A \$22.00 non-refundable transponder fee made payable to [Dunes Property Owners Association](#) for each vehicle registered.
7. Use of this unit is for single family residence only.
8. The seller (current owner) must provide the purchaser with a copy of the current Rules and Regulations and Condominium documents.
